IV. <u>Medical Examination</u>

The candidate shall undergo a medical examination, before the contract is entered into, for fitness to perform the work awarded to him/her.

V. Selection process

Interview will be conducted for selection of suitable candidates for the posts of Doctors & Paramedical Staff via online.

VI. Terms and Conditions:

- 1. The engagement of the Contract Medical Practitioner and Contract Paramedical Staff would be on the fulltime contract basis up to 30.09.2021. The service rendered during the contract is an arrangement for meeting up the requirement of the pandemic situation and it will not confer any right for automatic regularization/absorption in Southern Railway in any circumstances.
- The services rendered as Contract Medical Practitioner or Contract Paramedical Staff on contract basis is a stop gap arrangement and will not have any bearing in respect of consideration of their period of service in case of regular selection through RRB or UPSC.
- 3. Fulltime Contract Staff who enters into contract with the Railways will not have any claim of right for his/her regularization of absorption in railway service.
- 4. During the validity of contracts, the railway administration will be at liberty to terminate the contract at any time during the contract period for administrative reason whatsoever. The contract shall also be terminated forthwith if the work of contract staff is found to be unsatisfactory and the full time contract staff is found to be physically or mentally invalid or incapacitated.
- 5. Candidates proposed to be engaged on contract should be fit medically else will not be considered.
- After selection of the candidates for the posts required, the names of the remaining candidates who appeared in the interview will be kept on waiting list and in event of any vacancy arises in future, will be filled by these candidates.
- 7. The detailed instructions with regard to the duties shall be given to the candidates who are selected, along with the offer of engagement.
- 8. The candidates on contract are required to follow the <u>dress code</u> as per administrative requirement at their own cost.
- 9. The contract will be ceased on 30.09.2021 automatically.
- 10. The SC/ST/OBC candidates should submit a self-attested copy of the caste certificate issued by the competent authority in the prescribed Proforma. OBC candidates must ensure 'non creamy layer' certification and such certification should not be one year old at the time of Document Verification.
- 11. The selected candidate will be paid remuneration as noted in para-I mentioned above and the candidate cannot claim any additional remuneration allowances or other benefits during the course of contract period.
- 12. No TA/DA/Taxi/Conveyance charge shall be paid for appearing for walk-in interview.
- 13. No private practice or any other employment will be permitted during the contract period.
- 14. The candidates are personally responsible for payment of professional tax, income tax and other duties/taxes leviable by the State/Central Governments from time to time.

- 15. In view of lock down travel restriction preference will be given to candidates from Palakkad and same District/State.
- 16. The selected candidates must ready to work at any station in the Division.
- 17. The selected candidates have to arrange their own accommodation & transport facilities.
- 18. As part of Covid -19 preparedness a **panel** of eligible Doctors (Specialist and Non-Specialist) & Paramedical Staff will be prepared and kept ready, appointment orders can be sent later depending upon the demand and necessity arising for management of Covid 19 patient at Railway Hospital Palghat and Shoranur.
